- Number of Patients
- Use of Orphacodes

# Number of Patients

## Name:

Number of new patients referred to the Health Care Providers of the ERN, with the diagnosis of a disease or condition that falls within the scope of the ERN

## Definition:

Your ERN may require more detail but the EC only requires the total

The **total number** of patients attending the HCP **for the first time** during the reporting period, whose disease or condition falls within the scope of the ERN, **whatever their age and sex** (includes visits to outpatient's clinics, hospital discharges and emergencies, coming from national and international referrals).

# Use of Orphacodes

## **Name:**

Does your centre use Orphacodes?

## **Definition:**

Does your centre use Orphacodes **for classification** of rare clinical cases, (whatever the IT implementation in place at the hospital or at the centre)?

# Accessing the HCP form

1. The HCP designates a person to report – the reporter. It can be the HCP representative to the ERN, the sub-representative or other person.
2. The reporter creates (if not yet done) an EU login account and associates a mobile phone to the account. This process is common to all EU IT platforms. Detailed instructions can be found [here](#).
3. The reporter [submits](#) to the ERN a request to use the monitoring platform.
4. Once the request is approved by the ERN local admin, the reporter can [enter](#) the monitoring platform.
